LITTLE FLOCK WALK/BIKE ACTION PLAN

OVERVIEW


Little Flock is a suburban/rural community in northern Benton County whose city limits border those of Bentonville, Rogers and Pea Ridge. Little Flock has a population of 2,585 and covers 7.4 square miles. The community is characterized by low-density development in a rural and scenic landscape. Some roads through Little Flock are popular among cyclists due to their low traffic volumes and scenic attributes. Nearly all roads in Little Flock are narrow leaving little space for cyclists and cars to pass. Opportunities for improvement along several main roads through the community include shoulder improvements, allowing safer passage for motorists and cyclists. Most neighborhood roads and side roads in Little Flock are already excellent places to go for a walk/run or bicycle ride.








Program & Policy Recommendations

For many of these actions, there is an opportunity for the communities of the region to share resources, with individual communities participating in regional programs, attending trainings or meetings convened at the regional scale, or implementing regionally developed programs at the local level. Recommendations specific to the Six E's (Engineering, Education, Encouragement, Enforcement, and Evaluation (with Equity considered broadly through all)) are found below. Economy is included as an additional category to help demonstrate the benefits of implementing all of the E's. Refer to Appendix D for detailed guidance on implementing each item, including a description of recommended actions, regional and local roles, as well as sample programs.

RESOLUTION 2015-001

A RESOLUTION SETTING A PUBLIC HEARING DATE REGARDING THE MATTER OF ANNEXING CERTAIN TERRITORY SURROUNDED BY THE INCORPORATED LIMITS OF LITTLE FLOCK AND BENTONVILLE

WHEREAS, A.C.A. 14-40-501-14-40-504 provides that unincorporated islands of land that have been completely surrounded by the incorporated limits of two (2) or more municipalities may be annexed by the municipality with the greater distance of city limits bordering the unincorporated area's perimeter; and

WHEREAS, a determination has been made that the City of Little Flock has the greater distance of city limits bordering certain lands described below, an unincorporated island bordering the cities of Little Flock and Bentonville, same being Benton County Parcel #18-07681-000; and

WHEREAS, an ordinance has been introduced this date calling for the annexation of said unincorporated island into the City of Little Flock; and

WHEREAS, a public hearing must be conducted within sixty (60) days of the introduction of the ordinance to annex the said property.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LITTLE FLOCK, ARKANSAS:

That a public hearing before the City Council shall be held on February 16, 2015 at 6:00 PM, in the council chambers at Little Flock City Hall, to hear views regarding the proposed annexation of the following described property:

A part of the NE ¼ of the NE ¼ of Section 34, Township 20 North, Range 30 West of the fifth principal meridian, Benton County, Arkansas, and being described as follows: Commencing at the NE corner of Section 34, said point being a found iron pipe; Thence south 00°04′42″ west 800.00 feet and south 89°42′07″ west 431.88 feet to the true point of beginning, said point being in the roadway of Little Flock Drive, Thence leaving the roadway of Little Flock Drive, north 02°29′20″ east 371.67 feet to a set iron pin; thence north 88°01′34″ west 465.84 feet to a set iron pin; thence south 00°04′42″ west 389.71 feet to a set iron pin; thence north 89°42′07″ east 449.97 feet to the true point of beginning and being subject to the right-of-way of Little Flock Drive along that part of the south side and to all other easements or right-of-ways of record or fact.

Island Annexations (ACA 14-40-501 - 14-40-504)

-This method of annexation may be used when (1) the incorporated limits of a municipality have completely surrounded an unincorporated area; (2) the incorporated limits of two (2) or more municipalities have completely surrounded an unincorporated area. The municipality with the greater distance of city limits adjoining the island's perimeter may annex the area; however, they may defer annexation to another city with less perimeter distance; or (3) the incorporated limits of a municipality completely have surrounded an unincorporated area on only three (3) sides because the fourth side is a boundary line with another state, a military base, a state park, or a national forest.

Procedures

(1) An ordinance to annex the island is prepared, and introduced by the city council. This essentially announces the city's intention to annex the island. The ordinance will provide a legal description of the land (island) to be annexed; describe generally the services to be extended to the area to be annexed; and cite at least one of the criteria (A.C.A. 14-40-302) that makes the island suitable for annexation. (The attachment of a map, while not required, is recommended). While no action on the ordinance is to be taken at this time, a public hearing date must be set.

At the same meeting at which the ordinance is introduced, adoption of a **resolution** announcing the city's intentions to annex the island, and **setting** the **public hearing date** is recommended.

- (a) The **public hearing** shall be conducted **within sixty (60) days** of the introduction of the ordinance.
- (b) At least fifteen (15) days prior to the date of the public hearing, the city shall publish a legal notice setting out the legal description of the territory proposed to be annexed, and notify by certified mail all the property owners within said area of their right to appear at the hearing and make their views known. (Attaching a copy of a map showing the island is also recommended).
- (2) After due notice, as required, the public hearing is held at a council meeting.
- (3) At the **next** regularly scheduled **meeting following** the **public hearing**, the **city council** may bring the proposed ordinance up for a **vote**.
 - (a) If a majority of the total number of members of the governing body vote for the proposed annexation ordinance, then a prima facie case for annexation shall be established, and the city shall proceed to render services to the annexed area.
 - (b) The decision shall be final unless suit is brought in circuit court within thirty (30) days after passage to review the actions of the governing body.
- (4) A certified copy of the ordinance should be filed with all appropriate authorities.
