Open Public Comments:

Kim Wilson, 825 Wildflower Lane, Little Flock, AR, spoke of why Little Flock was formed and his opposition to the rezone.

Lisa Watson, 775 Wildflower Lane, Little Flock, AR, stated she agreed with Mr. Wilson, and other neighbors, in opposition to the rezone.

Marc Barry, 818 Wildflower Lane and 860 Wildflower Lane, Little Flock, AR, stated he stood with his neighbors in opposition of the rezone. Mr. Barry also stated his belief that the rezone does not conform to the Master Plan.

Bart Bauer, 3804 Copper Ridge, Little Flock, AR, stated he was the developer for the area to be rezoned, and that he had also developed Copper Ridge subdivision and felt it had turned out well. Mr. Bauer also stated the Planning Commission had already approved the rezone.

Close Public Comment

Council Members discussed water and drainage issues, as well as the potential for traffic issues. It was noted the current roads are not adequate to support the proposed number of increased households, especially as one of the roads remains partially unpaved. Several recommendations that a rezone to Residential Estates would be more suitable to the area under discussion and would be more in line with the Master Plan, were made. Council Members Jim Milholen, Chris Cantwell, Robbie Phillips, Doug Carmical, and Debb Formanek discussed issues, potential resolutions and the overall impact of the rezone.
