 Conditional Use Permit

Country Manor Chapel, formerly known as Country Rose Manor Chapel, is under new ownership. Owners, Tammy & Jason Wortham are going to operate the business in a similar fashion to the original owners; The Chesnutt's (Her parents). Mr. and Mrs. Engle applied for a Conditional Use Permit when they purchased it from Mr. and Mrs. Chesnutt in 2021. Tammy Wortham stood to speak and update the Conditional Use Permit for the chapel.

The name will change, the signage will be different, but most of the operations will continue as before. She was advised to apply for a sign permit before post a new one.
