1. Meeting called to Order:

Mary Jeff Van Sickler called the meeting to order at 6:00 PM.

2. Invocation & Pledge of Allegiance:

Council Member Rob Phillips gave the invocation, and the Pledge of Allegiance was recited.

3. Roll Call:

4. Public Comments:

The remaining ARPA funds were allocated as Police Salary expense, allowing the city to remove the reporting restrictions, and move the associated ARPA funding into the city budget. Council Member Rob Phillips made a motion to approve to amend the budget. A second was made by Council Member Wes Waddell.

- \$18,983.16 which was budgeted to purchase 6 laptops and docking stations for the police vehicles.

13. Adjournment:


