The City Council of Little Flock, Arkansas met in regular session on Monday August 21, 2023, at 6:00 PM in the Little Flock City Hall

## 1. Meeting called to Order:

Mayor Jeff Van Sickler called the meeting to order at 6:00 PM.

### 2. Invocation & Pledge of Allegiance:

Mayor Rob Phillips gave the invocation, and the Pledge of Allegiance was recited.

### 3. Roll Call:

Council Members present were Debb Formanek, Donny Barton, Robert Phillips, Wes Waddell, Jim Milholen and Chris Cantwell.

Others in attendance: Recorder/Treasurer Richard Crow and attorney George Rhoads

### 4. Public Comments:

Mayor Van Sickler opened the meeting for public comments.

Resident Bart Bauer spoke in favor of Ordinance 2023-007.

- Norman Wagoner, who lives in Bizmark, AR but owns property just outside Little Flock, asked about the process for subdivision applications. He was unable to find it online. Mayor Van Sickler provided the information requested and outlined the process for applying for a subdivision.
- Tony Wagoner spoke about the fact the property on Ordinance 2023-007 is in a civil dispute in the courts and shouldn't be considered for rezone. Attorney George Rhoads stated because it is a civil suit, the City has no liability in the situation. He also advised Mr. Wagoner to seek the advice of an attorney.
- Resident Nick Harrington stated that the property is in a trust. No parcels have been taken out of trust. Again, George advised that they should seek a personal attorney. There is no liability to the city.
  The city is not a party to the lawsuit and no cause of action to the City of Little Flock.
