Announcements:

Welcome Commissioner Marc Barry to his new seat on our Planning Commission. Mr. Barry is an Engineering Structural Consultant and hobby photographer.

Welcome Kathleen Russell as our new Finance Specialist. She is replacing Kimberly who has moved to the police department as the police chief's assistant.

Unfinished Business:

Conditional Use Permit Application: Approval to use "The Pavilion" for weddings. He already has a business license to operate as a short term rental at this location; owner Cory Gayer: 1102 Stratton Blvd.

- No citizens spoke out against this application. However, the discussion lasted an hour and a half.
- Mr. Gayer shared with us that he invited his neighbors to his venue, so he could address all their concerns. The concerns that were brought up include: parking, attendance, liquor and drunk driving on Little Flock roads, will it be used as a

sleep over, noise, lighting at night, and concerns about possible sex trafficking issues in this area.

- He pointed out that most of the parking will be in the back on grass where an old mobile home used to be referred to as the "Trailer Lot." Noise will end at 9:00 pm and rules are in place for volume levels of music. Liquor will be allowed to be brought in, but for weddings, he will have one of his professional bartenders work the wedding drink area and use Ubers if needed for guests, but hopes his bartender will be able to address this before an Uber is needed. He stated lighting wouldn't be an issue as the venue is surrounded by many trees.
- Mr. Gayer pointed out that none of his neighbors came to the Planning Commission meeting to argue against his venue after he visited with them.
- Other questions brought up include will there be a handicap accessible entrance and bathroom on the main floor? He said he would absolutely add this to his venue.
- Luke Moffitt pointed out that the Short Term Rental permit should not have been granted on Ag zoned land. This will be reevaluated in January, 2024. Many of the commissioners stated they were concerned about both the Short Term Rental and the Venue for weddings going on at the same time.
- Mr. Gayer pointed out that he ultimately wanted to do a "Members Only" venue and weddings open to the public.
- Some commissioners recommended that Mr. Gayer rezone to Residential Estates. Many commissioners stated they were ok with the wedding venue idea.
