The City Council of Little Flock, Arkansas met in regular session on Monday, September 16, 2024 at 6:00 PM in the Sunshine School Building following the destruction of Little Flock City Hall.

1. Meeting called to Order:

Mayor Jeff Van Sickler called the meeting to order at 6:00 PM.

2. Invocation & Pledge of Allegiance:

Alderman Rob Phillips gave the invocation, and the Pledge of Allegiance was recited.

Mayor Van Sickler asked if there were any changes or corrections to the August 19, 2024 City Council minutes. There were none.

The approximate grant money remaining is \$29K after purchasing, and equipping, a new truck (minus insurance).
